MANAGER COMMENTARY

October saw a rebound in global equity markets following a weak September. The MSCI World index was up 7.2% in US dollars and 3.9% in sterling, as the UK currency recovered somewhat from the lows experienced in late-September. The index was led by energy companies rallying significantly, and the portfolio's lack of exposure to the sector has been the main negative for relative performance this year. The broader market was also helped in the month by improving sentiment towards information technology firms. This was a benefit to the fund also but to a lesser degree as the bigger price moves were seen in companies not held in the portfolio. The main negative for relative performance in October was the consumer goods sector, which held steady in an overall rising market. Most positive for relative performance were communications firms and healthcare companies, where there was a rebound for service businesses such as Quest Diagnostics, and pharmaceutical firms Sanofi and GSK.

The third quarter reporting season has come around like clockwork, and we are seeing a continuation of the themes of the first half of the year. Revenue growth is strong, in some cases being driven by increasing prices particularly in the consumer goods sector. We get less information on margins and cash flow at this interim stage of the reporting cycle but it appears that there are some early signs of improvement from the pressures seen in the first half of the year. PepsiCo for example reported that commodity prices for purchases today are coming down. These reductions will feed through to their profit and loss statement in the coming six to nine months as the company buys its ingredients forward.

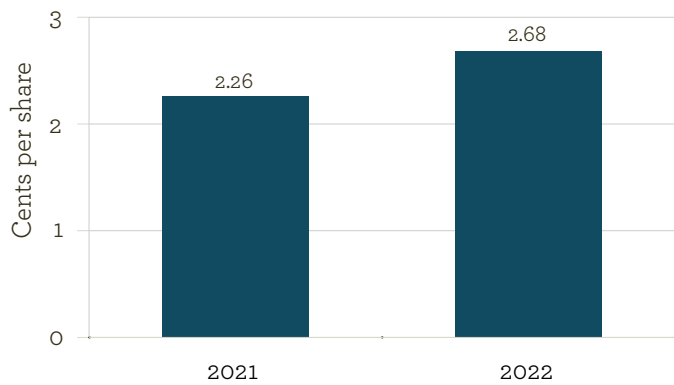

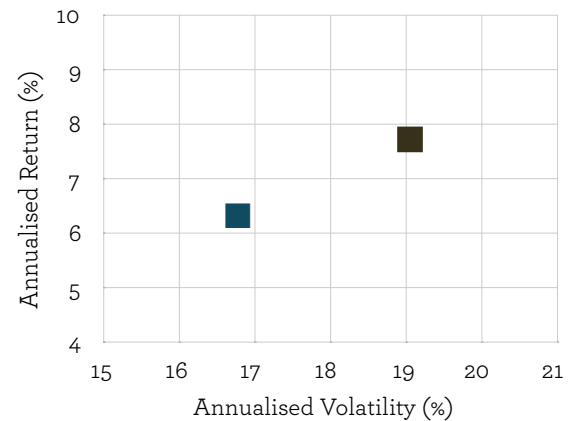
ANNUAL DIVIDEND PAYMENTS
