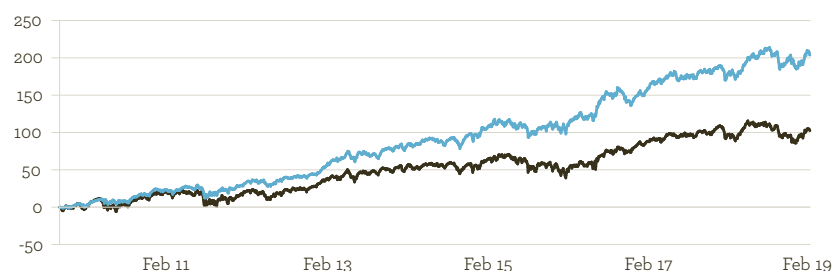
MANAGER COMMENTARY

Global stock markets continued to recover, helped by a significant reduction in US interest rate expectations and some stabilisation in leading economic indicators. On the home front, investor hopes regarding Brexit continued to increase. Evenlode Income rose +2.4% compared to a rise of +2.3% for the FTSE All-Share and +1.5% for the IA UK All Companies sector. Final results season has been in full swing, with most holdings now having updated the market this year. We've been encouraged by the steady strategic and financial progress that the aggregate Evenlode portfolio is making.

The fund's most positive contributors were Moneysupermarket, Sage Group and Astrazeneca. Moneysupermarket's final results demonstrated the benefits of recent investments, strong cash generation, a dividend increase of +6% and a supplementary return to shareholders as spare cash builds up on the balance sheet. Sage shares continued to recover following a strong trading update in January. Astrazeneca released results that demonstrated a return to revenue growth and a promising portfolio of both recently released and late-stage pipeline therapies. There were no significant negative contributors, though Reckitt and WPP shares drifted lower during the month. Both companies are currently experiencing operational headwinds but we think their valuations and long-term prospects are attractive, with recent final results demonstrating resilient free cash flow generation. We continued to add to several holdings including Hays, Schroders, Howden Joinery, Moneysupermarket, WPP, Page Group, Reckitt and Unilever where we see a good combination of valuation and dividend appeal.

On March 1st, the fund went ex a fourth quarter dividend of 240p (B Inc estimated). This brings the fund's full year distribution to 723p, representing annual growth of +4.3%. Looking ahead, the provision of real dividend growth over time remains a key aim for the fund, and we have been encouraged by recent dividend announcements in the portfolio.
